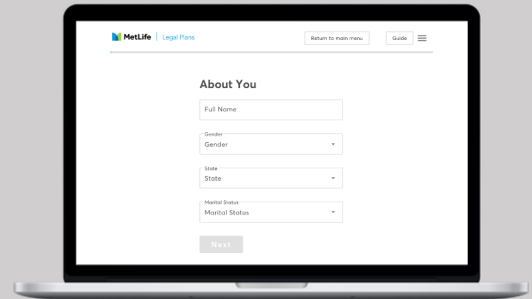

How to get started:

Create an account on legalplans.com using an email and password of your choice to access the service. **For the “Employer or Organization” field, select “Honeywell Aerospace from the drop-down list.**

1. Once your account is created, hit “continue” on the main page, and then choose “Wills & Estates” from the coverage menu.
2. Select the “Estate Plan bundle” and answer the questions to determine if the digital solution is the right fit for you.
3. Then select “Do it Online” to begin creating your documents.

Digital Estate Planning FAQs

Q: What documents can I complete through the digital estate planning solution?

A: The following documents are included:

- **Last Will and Testament** – Leave property to loved ones and choose guardians for minor children.
- **Living Will** – Plan for a medical emergency and select medical care preferences.
- **Durable Financial Power of Attorney** – Choose someone to manage finances in case of an emergency.

Q: Who can create a digital estate plan?

A: All **Honeywell Aerospace** employees have access to create these documents on the website through **9/30/26**. You can create an estate plan for yourself, as well as your spouse. You will be asked questions, then the spouse is asked the same questions. Once both have answered, two sets of documents are created; one for each spouse.

Q: What are the next steps after completing documents online?

A: After completing your documents, you will be directed to a screen to print them out. Then, simply sign your documents and follow the instructions on the cover page of each document. You will be given instructions on what needs to be notarized. Notaries are widely available at most banks, UPS, and FedEx locations.

Q: Are documents stored online?

A: Yes, documents will be saved within your account, and you can come back to access them at any time using your email and password to log back in. You can access these documents again by choosing the “wills and estate plan” option from the coverage menu. This will take you to the last page you visited in the digital estate planning document process, so that you can finish the documents or review.

Q: How would a member return to a Digital Estate Plan that was initiated during a free trial?

A: Your work is saved within your MetLife Legal Plans online account. Simply log in to the account that you created at members.legalplans.com, go to the **Wills & Estates** section, and click the **Estate Plan Bundle** option. You will need to answer a few questions to verify that Digital Estate Plan works for your situation and then select the **Create my plan now option**. This will return you to the Digital Estate Plan flow where you can finish or revisit your documents.

Q: What other services are a part of the Legal Plan?

A: You also have access to fully covered legal services through MetLife Legal Plans to contact attorneys for other legal issues that arise, including buying or selling a home, traffic matters, elder law and debt and identity theft issues.
